This Order is made by Lichfield District Council ('the Authority') under Section 257 of the Town and Country Planning Act 1990 ('the 1990 Act'), because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely the Demolition of existing social club and subsequent erection of 7no dwellinghouses under planning reference 19/01707/FUL

BY THIS ORDER:

- 1. The footpath over the land shown by a bold black line on the attached map and described in Part 1 ofthe Schedule to this Order ("the Schedule") shall be stopped up as provided below.
- 2. There shall be created to the reasonable satisfaction of Lichfield District Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the footpath shall take effect on the date on which Lichfield District Council certify that the terms of Article 2 have been complied with.
- 4. Mr Adam Cooper, The Old Council Chambers, Halford Street, Tamworth, Staffordshire B79 7RB is hereby required to pay the cost of carrying out the said works.
- 5. Where immediately before the date on which a footpath is diverted there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
- 6. The Order may be cited as "The Lichfield District Council Public Footpath Elford No.6 (Part) Public Path Diversion Order 2022"

Part I Description of Site of Existing Path

The full width of that part of Public Footpath No.6 in the Parish of Elford commencing at Grid Reference 418941 310467 (Point A on the Plan) and running in a generally east south easterly direction for a distance of approximately 59 metres to The Beck at Grid Reference 418998 310462 (Point C on the Plan)

Part II Description of Site of New Path

Public Footpath 3 metres wide commencing at Grid Reference 418941 310467 (Point A on the Plan), then proceeding in a south-easterly direction for approximately 46 meters to Grid Reference 418979 310441 (Point B on the Plan).
