

NOTICE OF PUBLIC PATH ORDER

Town and Country Planning Act 1990 Section 257

The Lichfield District Council (Public Footpath No.4 (Part) in the Parish of Streethay) Public Path Diversion Order 2025

The above Order was confirmed on 5 December 2025. The effect of the Order will be to divert that part of footpath No.4 (Part) in the Parish of Streethay commencing at Grid Reference SK 1282 1186 (Point A on the Plan) and running in a generally east south-easterly direction for approximately 54 metres to Grid Reference SK 1287 1184 (Point B on the Plan) on to a line commencing at Grid Reference SK 1282 1186 (Point A on the Plan), then proceeding in a south-easterly then easterly direction for a distance of approximately 60 metres to Grid Reference SK 1287 1184 (Point B on the Plan) as shown on the order plan.

A copy of the Confirmed Order and the Order Map may be viewed on the Council's website or at the offices of Lichfield District Council, District Council House, Frog Lane, Lichfield between 9am and 5pm Monday to Friday. Copies of the Order and map may be purchased.

The Order will come into force once Lichfield District Council certify that the new footpath has been provided to a satisfactory standard. Any person aggrieved by the Order, wants to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the above Act or any regulation made under it, has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town and Country Planning Act within six weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to the Act.

This Order is made by Lichfield District Council ('the Authority') under Section 257 of the Town and Country Planning Act 1990 ('the 1990 Act'), because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: Residential development off Watery Lane, Curborough under reference 21/01859/REMM & 22/00040/REMM

BY THIS ORDER:

1. The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be stopped up as provided below.
2. There shall be created to the reasonable satisfaction of Lichfield District Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
3. The diversion of the footpath shall take effect on the date on which Lichfield District Council certify that the terms of Article 2 have been complied with.
4. Redrow Homes Midlands of Redrow House, Kinsall Green, Wilnecote, Tamworth, Staffs B77 5PX is hereby required to pay the cost of carrying out the works to bring the new footpath into a fit condition.
5. Where immediately before the date on which a footpath is diverted there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
6. The Order may be cited as "The Lichfield District Council Public Footpath No.4 (Part) in the Parish of Streethay Public Path Diversion Order 2025"

The full width of that part of Public Footpath No.4 in the Parish of Streethay commencing Grid Reference SK 1282 1186 (Point A on the Plan) and running in a generally east south-easterly direction for approximately 54 meters to Grid Reference SK 1287 1184 (Point B on the Plan).

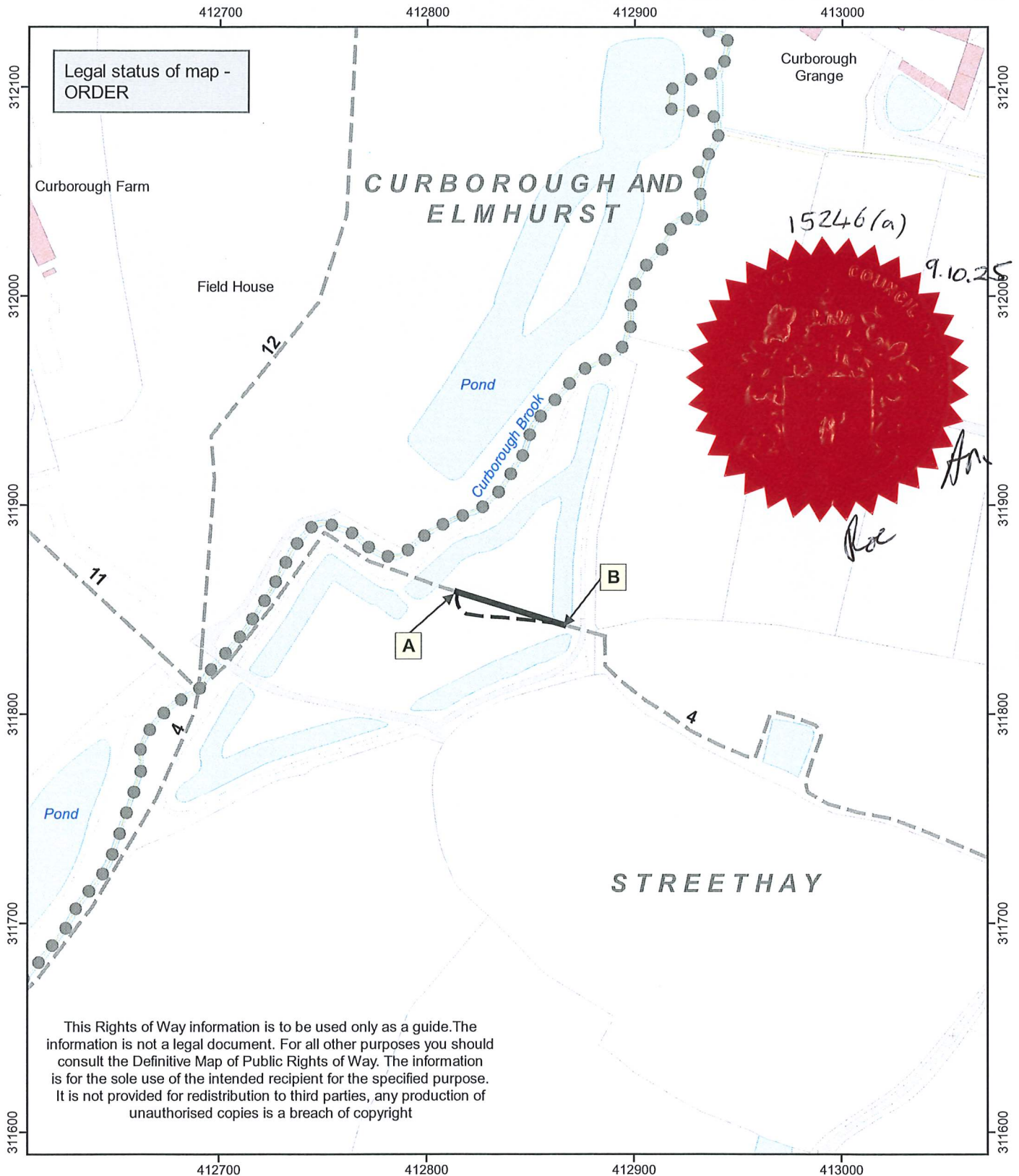
Description of Site of New Path
