### Determination of applications for individuals/associations to be included on the register

Notification of the authority's decision will be provided within 28 days of the date of the determination to:

- (a) in the case of an individual applicant, the individual;
- (b) in the case of an association, the lead contact or such other person as the authority considers to be action on behalf of the association.

Please note proof of personal details of any person requesting to be entered onto the register may be required.

### Amendments to register

Individuals or associations entered on the register may apply to amend that entry. Applications for amendments should be submitted in writing by the individual or, in the case of an association, the lead contact. Such amendments and notification of such will be determined in line with the timescales set out as above.

### Removal from the register

Lichfield District Council must remove an entry from the register within 28 days of receiving:

- (a) in the case of the individual, a written request from the individual to be removed from the register;
- (b) in the case of an association, a written request for the association to be removed from the register from the lead contact or such other person as the authority considers to be acting on behalf of the association.

Lichfield District Council may remove an entry from the register if the authority considers that the individual (or in the case of an association, any member of the association) is no longer eligible for entry on the register. Where it is decided to remove an entry from the register Lichfield District Council will notify the subject of the entry and give reasons for their decision. This will be made in writing and sent within 28 days of the date of the decision to:

- (a) in the case of an individual, the individual;
- (b) in the case of an association, the lead contact or such other person as the authority considers to be acting on behalf of the association.
